

FYI RICHARD ELTON ELLINGSON



Eureka Police received a call from local realtor Kathi Ray of Re/Max Realty. She stated the following:

Richard Elton Ellingson (dob 2/26/56) called her office requesting a meeting to look at real estate of vacant residences and requested a female realtor.

Ellingson states he has a “bunch of cash” and his girlfriend is out of the country and he would like to buy property in this area and needed a woman’s assistance.

Rey stated she would meet with him at her office. Ellingson kept his appointment and met with her today, 12/13/2016. He showed her a bank statement showing he had funds of \$5 million. He also showed her a South Carolina DL.

Ellingson stated he was working with Mark at Coast Central Credit Union.

Rey excused herself and went to a computer and Googled Ellingson’s name and noted that back in 2003 he was wanted in the Savannah area for bank theft by deception. He had over 15 aliases (see attached).

Ellingson wanted to see a property at Kneeland with 100 acres. Rey did not feel comfortable taking him/meeting him at this location.

Ray told Ellingson that she had another appointment and could not show him property today.

Ray also contacted CCCU and spoke with Mark to warn him of Ellingson’s background.

Ray wanted us to be aware of Ellingson. We told her we would send the information to local law enforcement.

Ray also stated that Ellingson arrived on foot and she did not see any vehicle associated with him.

Ellingson told Ray he was staying in a “flea bag motel” on Broadway.

A check of NCIC shows no wants on Ellingson at this time. He uses many aliases.

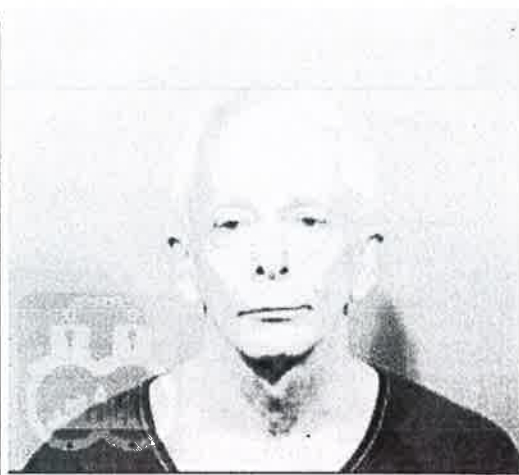

Option A) Bond: You may pay the full amount of the bond through Cashier's Check, Certified Check, or Money Order, made payable to the "Brevard County Clerk of Courts".

For Cash or Credit card, you may use Western Union or GovPay:

- Western Union – Go to a Western Union Office with Cash or Credit Card. Call Western Union at 1-800-325-6000 or go to www.WesternUnion.com/corrections (<http://www.westernunion.com/corrections>). For Commissary, give the code city of BREVCINMATE. For Bail/Bond, give the Code City BREVCOBAIL. Both code cities will require the Inmate's full name (Last, First) and date of birth.
